Member Selection Process

The Kossuth County Racing Hall of Fame was established in 2007 and seeks to recognize individuals, living or deceased, who distinguished themselves with a record of success or contribution to the betterment of racing in Kossuth County. Honorees must have lived in or raced in Kossuth County, Iowa.

The annual selection of honorees for induction as Kossuth County Racing Hall of Fame Members begins with the submission of the Nomination Application Form. Anyone is welcome to submit the completed application for consideration.

Nominee applications will proceed through the following process:

1. **Open Nomination Period (closes December 15th)** – Applications will be accepted during the calendar year from the general public. All applications must be submitted prior to December 15th for consideration during the next calendar year.
2. Applications will be reviewed by Kossuth County Racing Hall of Fame Committee.
3. Committee will select honorees (in January).
4. A maximum of eight individuals will be recognized annually.
5. Honorees will be recognized during the Kossuth County Fair Races and honorees name will be placed on the Wall of Fame located at the fairgrounds.
